ORDER:

During the 16<sup>th</sup> State Level Sanctioning Committee meeting of National Agriculture Development Programme held on 02.04.2018, among others; the project proposals of the Department of Horticulture and Plantation Crops were approved for the year 2018-19, for an amount of Rs.4344.935 lakh.

2. In the letter 2<sup>nd</sup> read above, the Government of India have made an allocation of Rs.165.20 crore as its share under NADP for the year 2018-19 and released a sum of Rs.82.60 crore as first installment. By adding the corresponding State share of Rs.110.13 crore, in the funding pattern of 60 : 40, between the Central Government and the State Government, the total allocation works out to Rs.275.33 Crore under National Agriculture Development Programme / Rashtriya Krishi Vikas Yojana for the year 2018-19.

3. In the letter 3<sup>rd</sup> read above, the Executive Director, Tamil Nadu Watershed Development Agency has prioritized the projects and have downsized the allocation for an amount of Rs.1788.00 lakh to the Department of Horticulture and Plantation crops as follows:-

4. In the letter 4<sup>th</sup> read above, the Director of Horticulture and Plantation Crops, after downsizing the cost, has sent the prioritized project proposals to the tune of Rs.1788.00 lakh under National Agriculture Development Programme 2018-19 to the Government for issue of sanction orders.

5. While moving the Demand No.5 on 12.06.2018, the Hon'ble Minister for Agriculture has interalia made the following announcements on the floor of Assembly:-

- I. தோட்டக்கலையில் வளமிக்க பகுதியாகத் திகழும் கிருஷ்ணகிரி மாவட்டம் தளி வட்டாரத்தில் செயல்பட்டு வரும் தோட்டக்கலை ஆராய்ச்சி மற்றும் பயிற்சி மையத்தில், தோட்டக்கலை சார்ந்த அனைத்துத் தொழில்நுட்பங்களிலும் விவசாயிகளுக்கு பயிற்சி அளிக்கப்பட்டு வருகிறது. கொய்மலர்களுக்கான மகத்துவ மையமும் செயல்பட்டு வரும் இவ்வளாகத்தில், நடப்பு ஆண்டில் மாநிலத்தில் தனித்துவம் வாய்ந்த பயிற்சி மையமாக மாற்ற மகளிர் விடுதி, அலுவலர்களுக்கு தங்கும் இடம் போன்ற கூடுதல் வசதிகள் ஒரு கோடியே 50 இலட்சம் ரூபாய் மதிப்பீட்டில் ஏற்படுத்தப்படும்.

- II. தோட்டக்கலை பயிற்சாலை சாகுபடி விவகாரத்துறை, நல்ல இனமும் உயர்நிலைப் பூண்டு ஆண்டி முழுமையும் மக்களுக்கு கிடைக்கவிரும்பும் ஒருவகை தரமுற்று மானியம் நடப்பு ஆண்டில் தனித்தனம் வாய்ந்த பழங்கள் மற்றும் காய்கறிகள், மலகைப்பயிர்கள், மலைப்பயிர்கள் மற்றும் நறுமணப்பயிர்கள் 44,250 ஏக்கர் பரப்பில் விநிவாகம் செய்வதற்காக, 34 கோடியே 45 இலட்சம் ரூபாய் நிதி ஒதுக்கீடு செய்யப்படும்.
- III. வெங்காயத்தை சரியான முறையில் சேமித்து, உரிய நேரத்தில் விற்பனை செய்தால், விவசாயிகளுக்கு நல்ல லாபம் கிடைக்கும். எனவே, நடப்பு ஆண்டில் சின்ன வெங்காயம் மற்றும் பெல்லாரி வெங்காயம் சாகுபடி செய்வதற்கு 40 சதவீதம் மானியமும், குறைந்த செலவில் 636 வெங்காய சேமிப்பு கிடங்குகள் அமைப்பதற்கு 50 சதவீதம் மானியமும், அனைத்து மாவட்ட விவசாயிகளுக்கும் வழங்கப்படும். இதற்காக, 2018-19 ஆம் ஆண்டில் 7 கோடியே 35 இலட்சம் ரூபாய் நிதி ஒதுக்கீடு செய்யப்படும்.
- IV. வீட்டுத் தோட்ட காய்கறி சாகுபடியினை ஊக்குவிப்பதற்காக, அரசு தோட்டக்கலை பண்ணைகளில் உற்பத்தி செய்யப்பட்ட ஐந்து காய்கறி வகைகள் அடங்கிய இரண்டு இலட்சம் காய்கறி விதைத்தளைகள் 40 சதவீத மானியத்தில் பொதுமக்களுக்கு விநியோகம் செய்யப்படும். இத்திட்டத்திற்கு 2018-19 ஆம் ஆண்டில் 20 இலட்சம் ரூபாய் நிதி ஒதுக்கீடு செய்யப்படும்.

6. Subsequently, the Hon'ble Chief Minister has made the following announcement on the floor of the Legislative Assembly under Rule 110 of Tamil Nadu Legislative Assembly on 14.06.2018:-

“காய்கறிகளை பசுமைக்குடில், நிழல் வலைக்குடில் போன்ற பாதுகாக்கப்பட்ட சூழலில் பயிரிடுதல், ஏறுகொடிகள் மற்றும் பற்று கொடிகளான காய்கறி மற்றும் பழங்களுக்கு ஆதாரமாக பந்தல் அமைத்தல், நிலப்போர்வை அமைத்தல் போன்ற தொழில்நுட்பங்களை மேற்கொள்ள 10 கோடி ரூபாய் நிதி வழங்கப்படும்”.

7. With a view to implement the announcement made by the Hon'ble Chief Minister on the floor of the Legislative Assembly under Rule 110 of Tamil Nadu Legislative Assembly and the announcements made by the Hon'ble Minister (Agriculture) while moving Demand No.5 on 12.06.2018, the Government examined the proposal of the Director of Horticulture and Plantation Crops and accord administrative sanction for a sum of Rs.1788.00 lakh for implementation of the project Nos.16.15, 16.17, 16.18, 16.19, 16.20 and 16.22 of the Director of Horticulture and Plantation Crops under National Agriculture Development Programme / Rashtriya Krishi Vikas Yojana 2018-19 and accord financial sanction for a sum of Rs.894.00 lakh (Rupees Eight Crore Ninety Four lakh only) being the 1<sup>st</sup> installment release, subject to the condition that under no circumstances any deviation from the decision of the State Level Sanctioning Committee is permitted. The funding pattern of the scheme is 60:40 sharing basis between the Central and State Governments.

8. Necessary additional funds of Rs.75.00 Lakh will be provided in Revised Estimate/ Final Modified Appropriation 2018-19 by the way of Re-appropriation from the head of account viz. "4401 00 103 UA 1600" to the head of account "4401 00 119 UA 1600", "4401 00 793 UB 1600" and to "4401 00 794 UB 16 00". Pending provision of such funds, the Director of Horticulture and Plantation Crops is permitted to draw and disburse the amount sanctioned in para.5 above to the Managing Director, Tamil Nadu Horticulture Development Agency (TANHODA) for the implementation of the projects. However, the expenditure shall be brought to the notice of Legislature by a specific inclusion in the Supplementary Estimate. He is also requested to include this item of

expenditure while sending the proposal for Revised Estimate / Final Monitor, Appropriation 2018-19 and also to send necessary explanatory notes for including the above expenditure in the Supplementary Estimate 2018-19 to the Government in Finance (Agri/BG I) Department at the appropriate time without fail.

9. The expenditure sanctioned in para. (7) above shall be debited to the Head of Account mentioned in the annexure to this order.

10. The funds available under existing Centrally Sponsored / Central Sector Schemes should invariably be tapped before using Rashtriya Krishi Vikas Yojana / National Agriculture Development Programme funds for the above projects. The projects should follow centrally prescribed cost norms and approved pattern of assistance. The Director of Horticulture and Plantation Crops should take due care to ensure that there is no duplication of subsidy.

11. The Director of Horticulture and Plantation Crops will be Estimating, Reconciling and Controlling authority to the above new sub head of account. The PAO / Treasury Officer's are requested to open the above new head of account in their accounts.

12. The Director of Horticulture and Plantation is permitted to fix the physical target based on the need and potential of the districts. Necessary relaxation of quarterly funds is given to the Director of Horticulture and Plantation for the effective implementation of the schemes in time.

13. The Director of Horticulture and Plantation Crops should personally oversee and ensure the technical, quality control and reasonableness of rates and estimates of the implementation of the schemes.

14. The Director of Horticulture and Plantation Crops shall observe the comments / suggestions of State Level Sanctioning Committee while implementing the projects.

15. The Director of Horticulture and Plantation Crops is directed to follow the RKVY-RAFTAAR operational guidelines while implementing the schemes.

16. The Tamil Nadu Watershed Development Agency which is the Nodal Agency, in consultation with the Head of Departments' to prescribe benchmarks for outcomes, milestones with time lines and monitor the outcomes through RDMIS to ensure that they are adhered to by the implementing departments.

17. The Executive Director, Tamil Nadu Watershed Development Agency is requested to send the monthly progress report to the Government of India, in the prescribed format by 10<sup>th</sup> of the subsequent month under intimation to this Government without fail.
