### **ORDER:-**

In the letter first read above, the Government of India have conveyed the Annual Action Plan 2018-2019 of National Horticulture Mission under Mission for Integrated Development of Horticulture with the total outlay Rs. 16333.00 Lakh. The assistance under the scheme is in the ratio of 60:40 by Central and State Government respectively.

2. In the letter second read above, the Government of India have released 1<sup>st</sup> installment of Central share Rs. 2500.00 lakh which includes

funds released under General category a sum of Rs.2000.00 lakh, SCSP category a sum of Rs.475.00 lakh and TSP category a sum of Rs.25.00 lakh for implementation of the National Horticulture Mission under Mission for Integrated Development of Horticulture Scheme (MIDH) during 2018-2019.

3. In the letter third read above, the Director of Horticulture and Plantation Crops has requested the Government to sanction and release a sum of Rs.41,66,67,000/- which includes Government of India share of Rs.25,00,00,000/- and State matching share of Rs.16,66,67,000/- as first instalment towards implementation of National Horticulture Mission under Mission for Integrated Development of Horticulture for the year 2018-2019.

4. The Government, after careful examination, accept the proposal of the Director of Horticulture and Plantation Crops / Managing Director, Tamil Nadu Horticulture Development Agency and accordingly sanction and release a sum of Rs.4166.67 lakh (Rupees Forty One crore Sixty Six lakh and Sixty Seven Thousand only) as first installment which includes Government of India share Rs.2500.00 lakh and State Matching share of Rs.1666.67 lakh towards implementation of National Horticulture Mission under Mission for Integrated Development of Horticulture during 2018-2019 in Tamil Nadu.
