ORDER:

During the Sixth State Level Sanctioning Committee meeting of National Agriculture Development Programme held on 19.11.2010 to sanction the project proposals for the year 2010-2011 under the Chairmanship of Chief Secretary to Government, a project proposal for **“Development of infrastructure facilities at Horticulture Training Centre, Thally, Hosur Taluk, Krishnagiri District”** with a total cost of Rs.300.00 lakhs (Rs.150.00 lakhs for the year 2010-2011 and Rs.150.00 lakhs for the year 2011-2012) was submitted by the Department of Horticulture and Plantation Crops before the State Level Sanctioning Committee for implementation. The State Level Sanctioning Committee has approved the above proposal with the following observations.

“SLSC approved the project and sanctioned Rs.150.00 lakhs”.

2. The Government after careful examination, accord approval for the detailed project proposal of Director of Horticulture and Plantation Crops for "**Development of infrastructure facilities at Horticulture Training Centre, Thally, Hosur Taluk, Krishnagiri District**" and sanction accordingly an amount of Rs. 150.00 lakhs (Rupees One Crore and Fifty Lakhs only) for the above purpose under National Agriculture Development Programme (RKVY) for the year 2010-2011 to the implementing agency i.e. Tamil Nadu Horticulture Development Agency (TANHODA) as detailed below, subject to the condition that under no circumstances any deviation from the decision of the State Level Sanctioning Committee is permitted and the amount sanctioned above for the project is 100% grant-in-aid under National Agriculture Development Programme (RKVY):-

3. The Government also direct that Tamil Nadu Horticulture Development Agency (TANHODA) should implement the project and Tamil Nadu Horticulture Development Agency (TANHODA) is responsible for the technical and quality control of the implementation of the project.

4. The funds available under existing Centrally Sponsored Central Sector Schemes should invariably be tapped before using Rashtriya Krishi Vikas Yojana / National Agriculture Development Programme funds for the above project. The project should follow centrally prescribed cost norms and approved pattern of assistance. The Managing Director, Tamil Nadu Horticulture Development Agency should take due care to ensure that there is no duplication of subsidy.

5. The expenditure sanctioned in para 2 above shall be debited to the Head of Account mentioned below:-

6. Necessary funds will be provided in the Revised Estimate / Final Modified Appropriation 2010-2011. However, it shall be brought to the notice of the Legislature by a specific inclusion in the Supplementary Estimates for 2010-11. Pending provision of such funds, the Commissioner of Horticulture and Plantation Crops is authorized to draw and disburse the amount sanctioned in para 2 above to Managing Director, Tamil Nadu Horticulture Development Agency (TANHODA) through crossed cheque.

7. The Commissioner of Horticulture and Plantation Crops is requested to send necessary Explanatory Notes for including the expenditure in Supplementary Estimates 2010-11 and in the Revised Estimates / Final Modified Appropriation 2010-2011 to Government in Finance (BG.I) Department at appropriate time.

8. The Tamil Nadu Watershed Development Agency which is the Nodal Agency shall prescribe benchmarks for outcomes, milestones with time lines and monitor the outcomes to ensure that the implementing agency adhere to them.

9. The Executive Director, Tamil Nadu Watershed Development Agency is requested to send the monthly progress report to Government of India, in the prescribed format by 10th of the subsequent month under intimation to this Government without fail.
