**ORDER:**

In the letter second read above the Commissioner of Horticulture and Plantation Crops has requested to sanction the continuance of City Vegetable Development Scheme in Chennai city during the year 2011-12 at an outlay of Rs.3.50 lakhs as it is an on-going Scheme.

The Government after careful consideration accord sanction for Rs.3.50 lakhs (Rupees three lakhs and fifty thousand only) to continue the City Vegetable Development Scheme in Chennai Metropolitan City during 2011-12, subject to the condition that the cost of the scheme excluding the expenditure of Rs.50,000/- on Vegetable campaign should be recovered in full through sale proceeds. 
