ORDER:

During the Eighth State Level Sanctioning Committee meeting of National Agriculture Development Programme held on 24.4.2012 to sanction the project proposals for the year 2012-2013 under the chairmanship of Chief Secretary to Government, among the others, the following project proposal of Department of Horticulture and Plantation Crops approved:-

2. The Government after careful examination, accord approval for the aforesaid detailed project proposals of the Department of Horticulture and Plantation Crops and sanction accordingly an amount of Rs.778.00 lakhs (Rupees Seven Crores and Seventy Eight Lakhs only) in respect of schemes announced on the Floor of the Assembly during Budget Session 2012-13 which are covered under National Agriculture Development Programme / Rashtriya Krishi Vikas Yojana for 2012-2013 to the implementing agency i.e. Department of Horticulture and Plantation Crops, subject to the condition that under no circumstances any deviation from the decision of the State Level Sanctioning Committee is permitted and the amount sanctioned above for the project is 100% Grants-In-Aid under National Agriculture Development Programme (RKVY).

3. The Government also direct that the funds available under existing Centrally Sponsored Central Sector Schemes should invariably be tapped before using Rashtriya Krishi Vikas Yojana / National Agriculture Development Programme funds for the above project. The project should follow centrally prescribed cost norms and approved pattern of assistance. The Department of Horticulture and Plantation Crops should take due care to ensure that there is no duplication of subsidy. The Government further direct that for the project of encouraging cultivation of pandal vegetable the subsidy should not exceed 50% and confined to small and marginal farmers for better beneficiaries coverage.

4. The Government further direct that the Department of Horticulture and Plantation Crops is responsible for the technical and quality control of the implementation of the project.

5. The expenditure sanctioned in para 2 above shall be debited to the Head of Account mentioned in the Annexure.

6. Necessary funds have provided in the Budget Estimate in 2012-2013 and the Commissioner of Horticulture and Plantation Crops is authorized to draw and disburse the amount sanctioned in para 2 above, in relaxation of quarterly restriction of funds.

7. The Tamil Nadu Watershed Development Agency, the Nodal Agency shall prescribe benchmarks for outcomes, milestones with time lines and monitor the outcomes to ensure that the implementing agency adhere to them.

8. The Executive Director, Tamil Nadu Watershed Development Agency is requested to send the monthly progress report to Government of India, in the prescribed format by 10th of the subsequent month under intimation to this Government without fail.
