ORDER:-

In Government Order first read above, the Government have sanctioned Rs.118.32 lakh as second installment for implementation of Paramparagat Krishi Vikas Yojana (PKVY) under National Mission on Sustainable Agriculture (NMSA) 2016-2017 with funding pattern of 60:40 between Central and State Governments.

2. In the letter second read above, the Government of India have released an amount of Rs.194.641 lakh as first installment for implementing Paramparagat Krishi Vikas Yojana (PKVY) under National Mission on Sustainable Agriculture (NMSA) for the year 2017-18. The above mentioned amount is for the pending activities of the existing 93 clusters for the year 2016-17 and the balance amount (50% of the Central share) for third year development of 93 organic clusters during current financial year 2017-18 and 50% of the Central Share for the first year programme of balance 19 clusters approved during 2015-16 for implementation during the year 2017-18.

3. Based on the above release, the Executive Director, Tamil Nadu Watershed Development Agency (TAWDEVA), in the letter 3rd read above has sent a consolidated proposal, received from the implementing departments i.e. Director of

Agriculture and Commissioner of Horticulture and Plantation Crops to the Government and stated as follows:-

- The Executive Committee has approved the Central share for an amount of Rs.203.041 lakh towards completion of first year and second year programme of 112 Clusters approved during 2015-16 and Rs.254.341 lakh (Central Share Rs. 152.604 lakh + State share Rs.101.736 lakh) for the third year programme of 93 clusters and Rs.501.785 lakh (Central Share Rs. 301.07 lakh + State share Rs.200.710 lakh) for the first year programme of 71 New clusters.
- Earlier, the Executive Committee, in its meeting held on 29.06.2015 had approved 112 clusters at an outlay of Rs. 799.46 lakh for the Implementation of PKVY scheme during the year 2015-16. Due to the revised allocation of Rs.666.22 lakh received from Government of India as against the original allocation of Rs.799.46 lakh, 93 clusters alone could be taken up for Implementation of the first and second year activities of PKVY and the first year activities of balance 19 clusters have to be taken up during 2017-18.
- The Government of India has released an amount of Rs.194.641 lakh as first installment under Paramparagat Krishi Vikas Yojana (PKVY) component of National Mission on Sustainable Agriculture (NMSA) for the year 2017-18 for the pending activities of the existing 93 clusters for the year 2016-17 and the balance amount (50% of the Central share) for third year development of 93 organic clusters during current financial year 2017-18 and 50% of the Central Share for the first year programme of balance 19 clusters approved during 2015-16 for implementation during the year 2017-18 and the programme has been consolidated as given below :-

4. The Executive Director, TAWDEVA has therefore requested the Government to sanction an amount of Rs.324.401 lakh (Rupees Three hundred (P.T.O.)

Twenty four lakh and forty thousand one hundred only) including the Government of India share of Rs. 194.641 lakh and State share of Rs.129.760 lakh as per the proposals given by the implementing Departments viz, Agriculture and Horticulture.

5. Further the Executive Director, TAWDEVA has also requested the Government to authorize the Director of Agriculture to draw and disburse 1% admin fund of Rs.6.658 lakh eligible in the capacity of Nodal Agency for National Mission for Sustainable Agriculture (NMSA) to Executive Director, TAWDEVA for depositing into the Savings Bank Account for incurring expenditure at Tamil Nadu Watershed Development Agency (TAWDEVA).

6. After careful examination, the Government accept the proposal of Executive Director, Tamil Nadu Watershed Development Agency (TAWDEVA) and sanction for a sum of Rs.324.401 lakh [(Rupees Three hundred twenty four lakh and forty thousand one hundred only) 60% of Government of India share Rs.194.641 lakh and 40% State share Rs.129.760 lakh)] including 1% administrative cost to Executive Director, TAWDEVA] as first instalment for implementation of PKVY under National Mission for Sustainable Agriculture (NMSA) during 2017-18 for the pending activities of the existing 93 clusters for the year 2016-17 and the balance amount (50% of the Central share) for third year development of 93 organic clusters during current financial year 2017-18 and 50% of the Central Share for the first year programme of balance 19 clusters approved during 2015-16 for implementation during the year 2017-18.

7. The expenditure sanctioned in para 6 above shall be debited to the Heads of Account annexed to this order.

8. Necessary additional funds of Rs.155.242 lakh will be provided in Final Modified Appropriation 2017-18 under the relevant head of accounts. Pending provision of such funds, the Director of Agriculture is permitted to draw and disburse the amount sanctioned in para 6 above. However, the expenditure shall be brought to the notice of the Legislature by specific inclusion in the Supplementary Estimate. The Director of Agriculture is requested to include this expenditure while sending the proposal for FMA 2017-18 and also to send necessary explanatory notes for including the above expenditure in the Supplementary Estimates 2017-18 to Government in Finance (Agri) Department at the appropriate time without fail.

9. The Director of Agriculture, Chennai is authorized to draw and disburse the amount to the implementing departments i.e., Managing Director, Tamil Nadu Horticulture Development Agency (TANHODA). The Implementing Departments shall scrupulously follow the National Mission for Sustainable Agriculture (NMSA) Guidelines given by the Government of India and follow the cost norms and pattern of assistance while implementing the project. They are also directed to ensure proper implementation of the project and complete them in time.

10. The Managing Director, TANHODA is authorized to operate the account through districts and requested to mention the department-wise physical and financial targets and head of account wise fund allocation for each department.

11. The concerned Assistant Directors of Agriculture are permitted to draw the advance amount for conducting Organic Farming Trainings @ Rs.20,000/training; Lead Resource Person Trainings @ Rs.400/cluster; for conducting Organic fairs @ Rs.36330/cluster and implementing Transportation of organic produce component @ Rs.1.2 lakh/cluster.

12. The Implementing Departments shall monitor the implementation process and progress at the State & District levels effectively and furnish the monthly progress reports to the Nodal Agency and to the Government simultaneously.

13. The Executive Director, Tamil Nadu Watershed Development Agency (TAWDEVA) is requested to send the monthly progress report by 10th of the subsequent month and the utilization certificate in the prescribed format to the Government of India under intimation to this Government without fail.
