- 3. The Government also direct that the funds available under existing Centrally Sponsored Central Sector Schemes should invariably be tapped before using Rashtriya Krishi Vikas Yojana / National Agriculture Development Programme funds for the above project. The project should follow centrally prescribed cost norms and approved pattern of assistance. The Department of Horticulture and Plantation Crops should take due care to ensure that there is no duplication of subsidy.
- 4. The Government further direct that the Department of Horticulture and Plantation Crops is responsible for the technical and quality control of the implementation of the project.
- 5. The expenditure sanctioned in para 2 above shall be debited to the Head of Account mentioned in the Annexure.
- 6. Necessary funds has already been provided in the Revised Budget Estimate in 2011-2012 and the Commissioner of Horticulture and Plantation Crops is authorized to draw and disburse the amount sanctioned in para 2 above in relaxation of quarterly restriction of funds.
- 7. The Tamil Nadu Watershed Development Agency is the Nodal Agency shall prescribe benchmarks for outcomes, milestones with time lines and monitor the outcomes to ensure that the implementing agency adhere to them.
- 8. The Executive Director, Tamil Nadu Watershed Development Agency is requested to send the monthly progress report to Government of India, in the prescribed format by 10th of the subsequent month under intimation to this Government without fail.
