ORDER:

The Commissioner of Horticulture and Plantation Crops has sent a proposal for Establishment of District Horticulture Extension and Training Centre Dharmapuri at a cost of Rs.30.00 lakhs.

2. In the letter second read above, the Commissioner of Horticulture and Plantation Crops has stated that the District Horticulture Extension and Training Centre at Dharmapuri is established with the objectives like demonstrations and dissemination of various advance technologies, One stop shop of all information regarding the scheme, Training to officials and farmers, Monitoring of schemes, Exhibition cum display centre and a Place for conducting seminars and shows.

3. Further, he has stated that Department of Horticulture has created awareness among the farmers about the Horticulture schemes and

the benefit out of cultivation of horticulture crops. Because of the high income out of horticulture crops, farmers are diverted towards the cultivation of horticulture crops every year and the area under horticulture crops is showing the increasing trend. Hence, advanced technologies are extended to farmers to improve the productivity of horticultural crops and ease out the farm operations like Mulching, Tissue Culture, Precision Farming, Micro Irrigation & Fertigation, Protected Cultivation, High Density Planting, Canopy Management, Farm Mechanization and Post Harvest Management. In order to adopt these advanced technologies and to utilize the schemes implemented by the Horticulture Department, the District Horticulture Extension & Training Centre is essential for the farmers.

4. The State Planning Commission has recommended the above scheme of the Commissioner of Horticulture and Plantation Crops under part II Scheme 2012-2013 as detailed below:
