#### ORDER:

During the Budget session 2020-21, the following announcements were made by the Hon'ble Chief Minister under Rule 110 of the Tamil Nadu Legislative Assembly and by the Hon'ble Minister for Agriculture respectively:-

"தமிழ்நாடு மக்களுக்கு தொடர்ந்து வெங்காயம் கிடைக்கும் வகையில், வெங்காய சாகுபடிப் பரப்பையும் உற்பத்தியையும் அதிகரிப்பதற்கு, 2020–2021 ஆம் ஆண்டில் ஐந்து கோடி ரூபாய் மதிப்பில் திட்டம் செயல்படுத்தப்படும்".

2. In the letter 1<sup>st</sup> read above, the 18<sup>th</sup> State Level Sanctioning Committee meeting of Rashtriya Krishi Vikas Yojana held on 26.02.2020, has approved the project proposals to the tune of Rs.435.056 Crore under Rashtriya Krishi Vikas Yojana for the year 2020-21.

- 3. In the letters 2<sup>nd</sup> read above, the Government of India, have allocated a sum of Rs.164.13 Crore for the year 2020-2021 as 1<sup>st</sup> instalment of Central Share for the year 2020-2021 for Rashtriya Krishi Vikas Yojana in the funding pattern of 60:40 between the Central and the State Governments. By adding the corresponding 40% State share of Rs.109.42 crore, the total allocation is worked out to Rs.273.55 crore. Government of India released a sum of Rs.82.05 crore [(General Rs.59.50 Crore) + (SCSP Rs.21.40 Crore) + (TSP Rs.1.15 Crore)] as 1<sup>st</sup> instalment for the year 2020-2021. By adding the 40% State share of Rs.54.70 crore the total release for the 1<sup>st</sup> instalment worked out to Rs.136.75 crore.
- 4. Based on the Government of India release, the Director of Horticulture and Plantation Crops, has sent the prioritized project proposals to the Government with a request to accord administrative sanction for a sum of Rs.25.588 Crore and financial sanction for a sum of Rs.12.794 crore under Rashtriya Krishi Vikas Yojana 2020-2021 as 1<sup>st</sup> instalment to implement the following projects including announcements:-

5. In the letter 4<sup>th</sup> read above, the Executive Director, Tamil Nadu Watershed Development Agency has prioritised and recommended the proposals of the Director

of Horticulture and Plantation Crops for sanction of funds for Rs.12.794 crore for implementation of the above projects.

- 6. In pursuance of the announcements made by the Hon'ble Chief Minister and by the Hon'ble Minister for Agriculture, the proposal of the Director of Horticulture and Plantation Crops has been examined by the Government. After careful examination the Government accord administrative sanction for a sum of Rs.25.5880 Crore (Rupees Twenty five crore fifty eight lakh and eighty thousand only) and financial sanction for a sum of Rs.12.7940 Crore (Rupees Twelve Crore Seventy Nine Lakh and Forty thousand only) as 1st instalment for implementation of the PP.Nos.18.18, 18.19, 18.20, 18.21, 18.22 and 18.23 to the Director of Horticulture and Plantation Crops, under Rashtriya Krishi Vikas Yojana for the year 2020-2021 subject to the condition that under no circumstances any deviation from the decision of the State Level Sanctioning Committee is permitted. The funding pattern of the scheme is 60:40 sharing basis between the Central and State Governments.
- 7. The amount sanctioned in the para.6 above shall be debited to the Heads of account and the targets annexed to this order.
- 8. Necessary additional funds of Rs.76,54,000/- will be provided in Revised Estimate / Final Modified Appropriation 2020-2021. Pending provision of such funds, the Director of Horticulture and Plantation Crops is authorized to draw and disburse the amount sanctioned in para.6 above to the concerned. However, the expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimate 2020-2021. The Director of Horticulture and Plantation Crops is directed to include this expenditure while sending the Budget proposal for Revised Estimate / Final Modified Appropriation 2020-2021 and also to send necessary explanatory notes for including the above expenditure in the Supplementary Estimates 2020-2021 to Government in Finance (BG-I / Agri) Department at the appropriate time without fail.
- 9. The Director of Horticulture and Plantation Crops is permitted to fix the physical target based on the need and potential of the districts. Necessary relaxation of quarterly funds shall be given to the Director of Horticulture and Plantation Crops for the effective implementation of the schemes in time.
- 10. The Director of Horticulture and Plantation Crops should personally oversee and ensure the technical, quality control and reasonableness of rates and estimates of the implementation of the schemes.
- 11. The Director of Horticulture and Plantation Crops shall observe the comments / suggestions of State Level Sanctioning Committee while implementing the projects.
- 12. The Director of Horticulture and Plantation Crops is directed to follow the respective operational guidelines while implementing the schemes.
- 13. The Tamil Nadu Watershed Development Agency which is the Nodal Agency, in consultation with the Head of Departments' to prescribe benchmarks for outcomes, milestones with time lines and monitor the outcomes through RDMIS to ensure that they are adhered to by the implementing departments.
- 14. The Executive Director, Tamil Nadu Watershed Development Agency is requested to send the monthly progress report to the Government of India, in the

prescribed format by 10<sup>th</sup> of the subsequent month under intimation to this Government without fail.

15. This order issues with the concurrence of the finance Department vide its U.O.No.21600/Fin(Agri)/2020, dated 03.08.2020 and Additional Sanction Ledger No.287 (Two hundred and eighty seven).
