

## **TNIAMP GUIDELINES**

### **Introduction:**

This scheme is proposed to be implemented from 2018-19 to 2023-24 in 66 sub basin and 32 districts with financial outlay of Rs. 210 crores

The scheme is funded by World Bank.

### **Implementation:**

The scheme is being implemented in 32 districts headed by the concerned Joint Director / Deputy Director of Horticulture of the District.

### **TNIAMP Implementing Districts:**

All districts except kanyakumari, Thirupur, Chennai and Nilgris

### **Area Selection:**

Since Geo tagging is proposed for TNIAMP documentation, the selection of area should be done only in specified sub basin only.

### **Beneficiary selections:**

1. Wide publicity should be given in the sub basin areas
2. Priority registers should be maintained.
3. TN IAMP area selection should be done only in specified sub basin areas.
4. Selection of farmers should be done based on cluster approach.
5. Since the area selected for TN IAMP should not clash with the areas of other schemes implemented by Department of Horticulture, the block officers should thoroughly verify the survey numbers of area selected for TN IAMP.
6. Preference will be given to the small marginal farmers SC/ST and Women farmers.

### **Eligibility of Farmers:**

Farmers having own land are eligible. If on lease, the lease period should be a minimum of 10 years.

Assured irrigation facilities are necessary where water usage is mandatory for the components like protected cultivation, crop demonstration etc.

The beneficiary farmers should enclose all mandatory documents along with the application.

The documents should be valid for the current period.

### **Documents to be submitted:**

1. Application form
2. Chitta and adangal (original)
3. FMB sketch
4. In case of lease farmers, registered lease agreement should be furnished
5. Soil and water test reports for cultivation related components
6. Passport size photos (3 Nos.)
7. Ration card (Xerox) / Aadhaar copy
8. Bank passbook (1<sup>st</sup> page Xerox) for polyhouse component verifying the Account Number.

### **TNIAMP Interventions:**

#### **A. Crop demonstration:**

1. Focus should be given for hybrid vegetable seeds.
2. The pedigree planting material should be distributed.
3. Maximum limit for vegetable – 2ha per beneficiary.
4. Maximum limit for fruits – 4ha per beneficiary.
5. Planting material to be sourced out from accredited nurseries.
6. Periodical inspection at various stages of the crop should be carried out 100 % by the block AHO, HO/Dy. HO and ADH and 25 % by the District JDH/DDH.

**Protected cultivation:**

1. MIDH guidelines should be followed.
2. Affidavit should be submitted wherein the assistance for poly house is above Rs.50, 000/- as a mandatory document.
3. All material should confirm BIS standards.
4. Test report for Polythene sheets, GI Pipes is mandatory.
5. Back ended subsidy payment should be done through RTGS to the eligible beneficiaries.

**Mulching:**

1. 50% subsidy as per MIDH guidelines. The maximum limit is 2 ha / beneficiary.

**Micro Irrigation:**

The PMKSY guidelines should be followed.

**Documentation:**

1. A spiral booklet must be maintained by the district officers for poly house and stages of the works with review notes should be recorded by pen.
2. Component wise success stories should be recorded by calculating the yield and income of the farmer in all stages,
3. A Separate photo album indicating details of the work for sub basin wise and district wise should be maintained year wise.
4. The farmer should display the board in the field.
5. After erection of the board a photograph with beneficiary farmer should be taken and affix in the beneficiary/ Follow up register.
6. Documentation should be done at different stages of crop as well as in distribution of inputs stage.
7. The photographs should be taken with geo reference details (latitude and longitude) using the specified apps and submitted.
8. The beneficiary list should be ready in both soft copies as well as in hard copy for any time verification by anybody.
