During the Agriculture Demand 2020-21, the Hon'ble Minister for Agriculture on 24.03.2020 among others made the following announcement on the floor of the Legislative Assembly:-

Based on the above announcement, the Managing Director, Tamil Nadu Horticulture Development Agency in his letter read above has sent a proposal for Establishment of Senganthal Poonga at an outlay of Rs.5.00 crore. He has furnished the estimated amount for establishment of Senganthal Poonga at an outlay of Rs. Rs.5.00 crore at the heart of the city of Chennai opposite to Semmozhi Poonga is given below:-


